I. EXECUTIVE SUMMARY

The Community Support Program (CSP) in Lebanon is an provide a range of support to underserved and vulnerable communities. Funded by the United States Agency for International Development (USAID) and implemented by Chemonics International, CSP seeks to improve the delivery of essential services and enhance economic opportunities to improve lives and reduce tensions that contribute to conflict and violence, primarily in Lebanon's North, South, and Beqaa Valley regions.

Through the IDIQ mechanism, USAID issued Task Orders (TOs) according to the following components: 1) community stabilization; 2) community development; and 3) technical assistance and capacity building. CSP uses a fast, flexible, and participatory approach to address a broad range of needs in Lebanon's most underserved and vulnerable communities in response to evolving political, security, and economic conditions. To achieve its objectives, CSP is partnering with municipalities, regional water establishments (RWEs), civil society organizations (CSOs), technical and vocational education and training (TVET) institutions, and the private sector, to implement four technical task orders: community support, workforce development, wastewater management, and technical assistance and capacity building.

The third quarter of Fiscal Year 2021 (FY2021 Q3), spanning April-June 2021, was characterized by a significant decrease in COVID-19 cases, a worsening of the economic crisis as the local currency continued to plummet, a slashing of subsidized goods, and an unprecedented fuel and electricity crisis, prompting further protests and roadblocks across the country. Despite these challenges, CSP's management and technical teams maintained business continuity and advanced assistance delivery to underserved communities. While this report focuses on CSP's progress and achievements during FY2021 Q3, the infographic on Page 3 includes cumulative results of CSP's programming since its inception in October 2018.

Following the easing of last quarter's lockdown measures, the community support component, also known as Task Order 2 (TO 2), focused on fast-tracking activity implementation while finalizing its remaining activity designs. This quarter, TO 2 received USAID's approval for two new activities, achieving a target number of 88 out of 89 approved activities. It's worth to note that following the quarter's end, TO2 met its target of 89 approved activities.


CSP's workforce development component falls under USAID's economic growth office and operates according to a different development objective and set of results. Although the team prepares their own quarterly progress report that is separate from the rest of the IDIQ's, this report provides a summary of the team's key accomplishments during the quarter. This includes the signing of 13 new MOUs with private businesses and SMEs and establishing ten new partnerships between TVETs and private sector firms to secure new internship and employment opportunities for TVET graduates.

CSP's wastewater management component, also known as Task Order 5 (TO 5) continued finalizing the 100% designs of its selected interventions. It equally launched the design process of two interventions and added an expansion component to another. TO 5, in collaboration with ECODIT Liban and the Association of Lebanon Industrialists (ALI), also conducted introductory field visits to various industries to discuss upgrades to onside wastewater treatment systems.

Finally, CSP's technical assistance component continued to design and implement technical assistance activities for municipalities, civil society organizations (CSOs), and community-based organizations (CBOs) to build the capacities of local partners and sustain the activities under CSP's other task orders. Capacity building trainings this quarter focused on organizational development, financial management, operation and maintenance, and social media management.

The technical teams are supported by the management and operations staff of TO 1, whose support in human resources, vetting, engineering and environmental compliance, and grants and subcontracts sustained programmatic momentum. Meanwhile, the monitoring, evaluation, and learning (MEL) team continued assisting all the technical teams to note possible points of improvement for future programming based on lessons learned. In parallel, the communications and outreach unit ramped up its efforts to promote the program by highlighting ongoing activities through traditional media and online outlets.

The rest of this report details the progress made by each TO under the CSP IDIQ during FY2021 Q3. After providing a more detailed overview of the country context impacting CSP's work during the quarter, this report details the progress achieved under the community support and wastewater management components, as well as a briefing page with more information about the workforce development team's successes. There are then updates from the quarter on how the technical assistance component enhanced the other three components' activities and while Task Order 1 provided operational and management support. Finally, the report includes a series of annexes such as charts, maps, and other supplementary material to augment the narrative of CSP's progress.



II. COUNTRY CONTEXT

The third quarter of FY2021 (April-June 2021) was characterized by a significant decrease in COVID-19 cases, following a prolonged national lockdown. The Government of Lebanon (GoL) ramped up its national vaccination campaign, and new cases decreased from last quarter's daily average of 6,000 case to just 100 infections per day. Following this progress, many countries moved to include Lebanon in their 'Green' travel lists.

On the other hand, this guarter was also marked by a worsening of the economic crisis and further devaluation of the national currency, which reached historic lows valued at about 15,000 Lebanese Pounds (LBP) to USD \$1 on the alternative market, compared to the official rate of LBP 1,507 to \$1. The tenfold devaluation of the currency, and the government's gradual and ad-hoc lifting of subsidized foodstuffs, fuel, and other essential goods, has further increased households' living costs, resulting in more than half of the population plunging below the poverty line.

The Government of Lebanon remains in caretaker status after almost a year of deadlock and the Central Bank has been slashing import subsidies, including on petroleum products, provoking an unprecedented fuel shortage as well as increasing power cuts across the country. Residents have had to gueue for several hours each day at gas stations to refill their vehicle tanks only partially. Most households have only a few hours of state-provided electricity and are receiving increasingly limited back-up power from private generator memberships. As a result of the unfolding cuts on imported goods, the consequent deterioration of living conditions, and political instability, this quarter witnessed an increase in civil unrest, protests, roadblocks, and crime across the country.

CSP's field teams faced a new set of challenges related to the continued deterioration of the economy and further devaluation of the national currency. There were significant shortages in the market supply of construction materials and other necessary equipment, which provoked some delays in construction-related activities. In addition, the fuel crisis and the resulting difficulties for staff and contractors to travel on-site caused some delays in field activities.

III. COMMUNITY SUPPORT

Under the community support component, Task Order (TO) 2, CSP collaborates with local partners to implement short- and medium-term interventions to improve livelihoods and ensure access to services, thereby alleviating sources of tension among communities.

During the third quarter of FY2021, TO 2 focused on fast-tracking activity implementation following the gradual reopening of the country after last quarter's prolonged national lockdown measures, whilst finalizing the remaining activity designs. Although CSP immediately pushed to ramp up activities' implementation, the team continued to face challenges and delays. As the economic crisis worsened this quarter, suppliers decreased imports, leading to a supply shortage of materials required for activity implementation. Specifically, the unavailability of concrete at a local supplier level caused significant delays to construction-related activities. Activities faced further setbacks due to the unexpected need to import technical materials, such as LED lights and welding station supplies. The deteriorating fuel crisis has also increased state-provided electricity cuts and the rationing of power supply by private generators, requiring CSP to adapt and coordinate closely with partners and suppliers to plan innovative and effective tactics to ensure provision of needed support to beneficiaries.

This quarter, CSP's TO 2 received USAID's approval on two activities in North Lebanon: the first to enhance security and municipal service delivery in Bqarsouna (NTH044), and the second to improve the recyclables collection and management system at the Amioun Material Recovery Facility (NTH043). On the other hand, two activities were retracted by CSP in South Lebanon due to the complexity in providing the legal documents to proceed with their implementation. Of the remaining pending activities, BQA018 with the Majdel Anjar Cooperative was pending additional information ahead of requesting USAID's approval.

CSP made significant progress in the implementation of approved activities this quarter. By the end of June 2021, 57 activities were under implementation and 31 were either completed or closed. For a summary of TO2 activities under implementation this quarter, refer to the visual below.

To date, 308,025 beneficiaries of the current target of 645,580, have benefitted from USAID assistance under CSP's community support component — of whom 54 percent were female and 29 percent were youth (18-29 years old).

Some additional highlights of CSP's results under TO 2 this guarter are:


- **5,440 people** recorded as benefiting from U.S. government (USG) assistance.
- **54 percent** of the participants in USG-assisted programs were female.
- Two local actors have enhanced abilities to provide better services as result of USG support.
- 17 community members have participated in the CSP activity cycle.
- ⊙ 5,100 people reported having access to adequate levels of essential services.

ACTIVITY DESIGN

ACTIVITY CONCEPTS

Although this quarter CSP's TO 2 prioritized activity implementation over the design of new interventions, CSP submitted three new activity approval packages (AAPs) to USAID for review and received approval for two, bringing the total number of approved activities to 88 by the end of June. The approved interventions include a recyclables management intervention in Amioun, North Lebanon, and a streetlight rehabilitation activity coupled with the provision of a snowblower and salt spreader in the remote municipality of Bgarsouna. The last AAP, still pending additional information by CSP to receive USAID's approval, includes the support of a cooperative in Majdel Anjar to enhance income-generating opportunities.



In parallel, the TO 2 team submitted three concept notes (Hasroun and Wadi Kadisha in the North,

and Kawkaba in the South), which aim to facilitate access to water and electricity in case additional funding were to become available for activities beyond the current target of 89. The activities in Hasroun and Kawkaba include the provision of water pumps with solar power, while the activity in Wadi Kadisha is a construction project to rehabilitate a water channel that feeds a hydroelectrical station. However, the latter was retracted due to the negative reputation of the potential partner.

Additionally, CSP conducted two community profiling exercises in the Beqaa (Kfar Qouq and Kfar Denis) and identified water scarcity as a critical challenge for both municipalities. As a result, CSP explored solar interventions for water provision to mitigate prolonged electricity cuts.

ACTIVITY IMPLEMENTATION

At the end of FY2021 Q3, TO 2 had committed of the approximately activity budget, under 88 approved activities. The expected number of overall beneficiaries for these activities is more than 800,000 residents from underserved communities. A sector-by-sector breakdown of committed funds, with the estimated number of beneficiaries according to the number of interventions, is shown in the visual below.



As mentioned earlier in this report, by the end of June 2021, CSP reached a total of 88 approved activities, 31 of which were either completed or closed, and 57 were under implementation. Overall, of the 57 activities currently under implementation, 24 are in North Lebanon, 18 in the Begaa, 14 in the South, and one in Beirut.

As CSP focused on accelerating the implementation of activities following the lockdown measures last quarter, the team launched the procurement process for clusters of activities beginning implementation next quarter. These included:

- Streetlighting in the Begaa for the villages of El Mari, El Qaraoun, and Hawch Barada;
- Recyclables management in Manara and Makse in the Beqaa, and Ras Nhach, Bechmizzine, and Amioun in the North
- O Provision of backup generators in Aaiha, Deir el Ghazal, Dahr el Ahmar, and El Ansar in the Begaa.

During this quarter, CSP made significant progress towards the implementation of large construction activities, such as rehabilitating the main irrigation channel in Ras Baalbek (Beqaa), and rehabilitating the irrigation distribution network in Aachach, Meriata, and Arde (North). CSP continued to support neighborhoods affected by last year's explosion in the Port of Beirut. Support included the groundworks for the installation of LED streetlights and concluding the temporary provision of portable latrines for workers at the port. CSP also completed the implementation of two laborintensive work activities to provide underserved residents with short-term income generating opportunities by hiring them to carry out low-risk labor intensive interventions, including forest cleanup in Chouf area, and forest cleanup coupled with the pruning and cleaning of irrigation canals in Al Hasbani area in the South. Both interventions temporarily alleviated the impact of the ongoing economic crisis for around 3,000 beneficiaries. In parallel, CSP's TO 2 concluded the first phase of a labor-intensive income generation activity in Qalamoun and Deddeh, in the North, which entailed the cleanup of a two-kilometer footpath in preparation for labor-intensive construction works in the coming quarter.

The following subsections provide further details about ongoing, closed and completed activities as of June 2021. For a full account of all AAPs submitted by CSP for USAID approval — including approved activities; activities pending design, USAID approval, or CSP revision; and activities CSP did not to proceed with — please refer to Annex C: CSP TO 2 Activity Tracker. ACTIVITY HIGHLIGHTS

ALMOST A YEAR INTO THE BEIRUT BLAST, CSP CONTINUES SUPPORT TO AFFECTED COMMUNITIES

On August 4, 2020, the explosion at the Beirut Port left surrounding neighborhoods in rubble and damaged basic infrastructure. Following the blast, and given the wider economic crisis across the country, CSP rapidly responded to implement a labor-intensive income generating activity to support underserved residents with the clean-up effort in the damaged neighborhoods. The intervention created temporary income for more than 340 people, who removed around 4,250 tons of rubble

and debris and received a cumulative total of around

. CSP launched another intervention in October 2020 to address worker sanitation needs at the port in order to contribute to mitigating any slowdown in work or productivity at the Port which can reverberate into delays in providing basic construction materials, food stuffs, and appliances for blastaffected neighborhoods and residents. This included the provision of eight portable toilets equipped with running

water, soap, towels, and other sanitary materials. The initial three-month activity was later extended until April 22, 2021, due to the need to continue maintaining the pace of work and productivity at the port for the welfare of the blast-affected neighborhoods.

The latrines improved the working and health conditions for 240 workers and drivers at the port of Beirut.

In May 2021, CSP kicked off its third activity related to the Beirut Port blast, to supply and install

around 500 LED streetlights in surrounding neighborhoods to replace the destroyed or damaged sodium lights. The intervention came at a time when residents in blast-affected areas reported feeling unsafe and insecure after sundown especially amidst an increase in crime rates. On May 26, CSP inspected and tested sample streetlights. Batches of streetlight shipments are expected to arrive in Beirut during the first week of July, so



CSP is planning to fast-track the installation of streetlights in the next quarter. Worth a total of

in USAID funding, this emergency response activity will address the pressing needs of more than 50,000 underserved residents hit hardest by the blast.

CSP KICKS OFF A RANGE OF NEW ACTIVITIES TO SUPPORT NORTH LEBANON'S MOST UNDERSERVED AREAS

As the national COVID-19 lockdown measures were further eased by the beginning of this quarter, CSP launched an array of activities across its regions of implementation that respond to vulnerable communities' increasing needs, ranging from electricity provision and recyclables management, to wastewater treatment and the supply of irrigation water to local farmers. The program's flexibility allowed for the design of diversified interventions to support underserved areas in overcoming the multiple crises that continue to affect the country. Particularly in North Lebanon, one of the country's hardest hit regions by the ongoing health, economic, and financial crises, the team launched a series of new activities to enhance service provision and reduce inter-communal tensions.

In Khirbet Daoud, a large host community in Akkar with over 5,000 Syrian refugee residents, has been struggling with weak infrastructure that is significantly affecting its electrical transmission system and ability to provide electricity to households at 220 voltage. On May 19, CSP's construction contractor was deployed to the site to initiate the groundworks of building a new electrical transformer room on land offered by the municipality . By the end of the quarter, over 70% of the work has been completed.

In parallel, CSP started implementing an activity benefiting farmers in Aachach, Meriata, Arde, and the Zgharta district, to improve field irrigation through the construction of a water distribution



station and the rehabilitation of the area's existing water irrigation canal. This intervention comes at a critical time for farmers who had been struggling to make profits amidst the continuous devaluation in the national currency, and consequent price inflation and rising production costs.

Finally, in the Koura district, CSP launched a coordination process between the municipalities of Bechmizzine and Amioun on recyclables management. This activity facilitated the division of around 40 villages between two Materials Recovery Facilities (MRFs), and determined a standardized approach to recyclables management across the district. Through the provision of needed equipment, such as recycling bins and metal cages, CSP aims to improve recyclables management for over 100,000 residents across the Koura district. Worth more than USAID funding, the above activities, which target an array of basic services, aim to provide support to North Lebanon's most underserved communities.

IMPLEMENTATION CHALLENGES, LESSONS LEARNED, AND NEXT STEPS

During the reporting period, CSP's community support component faced challenges stemming from the difficult operating context in Lebanon, mainly due to the worsening economic and fuel crisis and resulting nationwide protests and roadblocks, which forced public institutions, municipalities, and private businesses to slow down work in CSP's focus regions. Work productivity of public sector employees was also negatively affected as currency devaluation reduced their purchasing power by approximately 90%.

Following the strict nationwide lockdown measures during the previous quarter, several activities faced associated delays at different intervals during this quarter. For instance, under the recyclables waste management activities, CSP's activity in Bechmezzine (NTH025) suffered from delays due to the Ministry of the Environment's inability to conduct a meeting and issuing a recommendation addressing the screening form submitted by the Municipality. In response, CSP's local partner, the Bechmezzine Municipality, followed up with the Ministry of Environment to take the necessary steps enabling the activity works to resume.

Other approved activities faced weeks of implementation delays due to the unavailability of material. In Bqasta (STH006), where CSP is constructing an elevated water tank, the contractor was unable to source concrete from the local market and therefore had to pay increased rates to procure the materials and resume works. In Hawch Barada (BQA032), where CSP is enhancing safety and security through installation of LED lightings, and El Marj (BQA033) and El Qaroun (BQA034), where CSP is replacing streetlights with LED bulbs, vendors required additional time for the procurement of materials as limited stocks were available. Measures were immediately taken, however, to import the required materials to prevent further implementation delays and delivery is expected in August, September, and October respectively. Similarly, in Marfaa, Rmeil, Saifi and Medawar (BEI002), where CSP is installing 500 LED streetlights to promote safety and security in eastern Beirut, the vendor was forced to ship the LED lights by plane to fast-track activity implementation. The lights have been shipped and are expected to be cleared and installed by the end August to early September.

Additional activities experienced delays due to frequent roadblocks, particularly in the North region. For instance, the activities of Beit Mellat (NTH035), Tikrit (NTH037) and El Borj (NTH038), where CSP is installing an on-grid water pump solar system, were all affected by the inability to collect water samples and have them delivered for testing, which delayed the activities' detailed designs.

In addition, the large volume of interventions approved earlier in the year with construction components resulted in a confluence of interventions requiring detailed engineering designs at the same time. CSP's subcontractor for construction design was not adequately staffed to manage a large backlog of interventions leading to delays in the implementation of some interventions, notably Bechwat (BQA031), Jebrayel (NTH040), and Mazraat et Teffah (NTH036). BTD has since added a number of specialized engineers to its roster to match the required expertise with the nature of CSP's interventions, and CSP and BTD engineering teams are continuously meeting to expedite the process and fast-track the designs.

Despite all the above-mentioned challenges, CSP's TO 2 continued to seek out opportunities for collaborating, learning, and adapting its programming accordingly. For instance, in Majdlaya (NTH034) the activity which consisted of providing bins for recyclables and promoting sorting at source was facing challenges related to the environmentally incompliant Material Recovery Facility (MRF) in the village. Therefore, the team linked the municipality with another MRF in Bechmezzine which is supported under the NTH025 activity. In the upcoming quarter, CSP will continue finalizing the revisions of the remaining activities under design, while continuing to shift its efforts fully to implementation of interventions. In parallel, CSP will also work towards closing out completed activities.

IV. WORKFORCE DEVELOPMENT: BRIEFING PAGE

To improve the skills of and employment opportunities for at least 1,000 unemployed or underemployed Lebanese citizens from vulnerable communities, CSP continues to support underserved residents wishing to pursue Technical and Vocational Education and Training (TVET). This quarter, CSP's TO4 developed a soft skills curriculum and initiated trainings with TVET partner institutes on its delivery. Additionally, TO4 produced and disseminated a video promoting its upcoming repair and maintenance course and initiated the official accreditation process for its vocational curricula. Other specific achievements by the WFD team from Q3 are as follows.



The WFD team signed MOUs with 13 new private businesses/SMEs across Lebanon that committed to providing internship placements to JET scholarship recipients. A geographical breakdown of the new partner businesses per sector, and the number of internships offered by each, is shown in the visual to the right.

LINKAGES BETWEEN TVETS AND THE PRIVATE SECTOR

This quarter, ten 'Linkages-Partnerships Agreements' were signed between three CSP partner TVETs (St. Elie Technical Institute in North Lebanon, Foyer de la Providence in the South, and Foyer de l'Amitié in the Begaa) and private



sector businesses/Small and Medium Enterprises (SMEs) within the TVETs' geographical areas. The signed agreements indicate the commitment of the ten businesses/SMEs to provide internship placements for Jobs, Education, and Training (JET) scholarship recipient graduates.


FACT-FINDING STUDY OF THE TVET SECTOR IN LEBANON

CSP initiated a fact-finding study which aims to identify major trends, challenges, and areas for reform or development within the TVET sector in Lebanon. The study, which is still in its early phase, will serve to inform future planning and implementation of CSP's WFD component, and support in establishing synergies among stakeholders.

V. WASTEWATER MANAGEMENT

Under its wastewater management component, also known as Task Order 5 (TO 5), CSP is collaborating with the Ministry of Energy and Water (MoEW), regional water establishments (RWEs), the Litani River Authority, municipalities, and local communities to design and implement interventions that mitigate pollution resulting from the discharge of untreated domestic and industrial wastewater.

Early this quarter, CSP's TO 5 received USAID approval of the Addendum to the Selection of Proposed Wastewater Infrastructure Interventions report. The revised selection was submitted in response to external changes affecting the program as was reported last quarter. Accordingly, CSP continued finalizing the 100% designs of the 5 originally selected interventions, although Sainiq will not be implemented, while launching the design process of 2 additional interventions and adding an expansion component to the originally selected last Wastewater Treatment Plant rehabilitation intervention. The implementation of the Sainiq Valley Wastewater Conveyance System was replaced by the Lower Litani Trunk Sewer, a higher priority project that was awarded by MoEW but was halted due to the financial crisis in the country. The resulting 6 interventions are depicted in the graphics below:



- I- laat Wastewater Treatment Plant Rehabilitation and Expansion
- 2- Aaitanit Treatment Plant Rehabilitation and Sludge Mnagement Upgrade
- 3- Lower Litani Trunk Sewer and Networks
- 4- Rehabilitation of En Nmairiye Pumping Station and Access Road
- 5- Borj Rahhal Wastewater Pumping Station and Forcemain
- 6- Bchaaleh Wastewater System

CSP also held a virtual launching ceremony of the Industrial Wastewater Treatment (IWT) project, being implemented by the Association of Lebanese Industrialists (ALI) under a grant with TO 5. Under this grant, ALI is administering a rebate program to encourage Lebanese industries to reduce their wastewater output. Several agri-food industries expressed interest in the program and are currently being evaluated by an environmental consultant engaged under the grant to ensure suitability of the intervention, as detailed later in this report.

WASTEWATER INFRASTRUCTURE

SELECTION OF THE WASTEWATER INFRASTRUCTURE INTERVENTIONS

The six originally selected interventions in April 2020, were revised this quarter to meet several emerging external challenges, as the MoEW halted several ongoing high priority wastewater infrastructure projects due to the financial crisis in the country. Accordingly, CSP selected the following MoEW projects to complete:

LOWER LITANI TRUNK SEWER: CSP's selected intervention for the Borj Rahhal Watewater Pumping Station (WPS) and Forcemain was initially evaluated in conjunction with a halted MoEW project which aimed to construct a trunk sewer that would convey wastewater from numerous towns along the lower Litani River basin to Borj Rahhal. Since the trunk sewer project was essential for the viability and sustainability of the selected Borj Rahhal intervention, CSP made the decision to implement it. This decision resulted in CSP not implementing the lower priority Sainiq Valley Collection System Rehabilitation intervention due to budget constraints, a decision fully supported by MoEW and the South Lebanon Water Establishment (SLWE). Its completed design, however, will be turned over to SLWE for future implementation.


BCHAALEH WWTP AND COLLECTION SYSTEM: After completing 80% of the collection system, MoEW was forced to cease this project due to the worsening economic crisis. Considering its high priority for the MoEW, and to safeguard the already implemented portion of the system, CSP decided to complete the remaining 20% of the collection system, as well as designing and constructing its WWTP. Once completed, this intervention will be the only wastewater treatment plant project in North Lebanon implemented under CSP's wastewater management component.

IAAT WASTEWATER TREATMENT PLANT: The MoEW recently implemented a new extension to the wastewater network in Baalbek which would result in an excess of the current 15,000 m3/d design flow capacity of laat WWTP. The introduction of a higher flow than the plant could process would result in inadequate treatment of the influent and would not meet the Environmental Limit Values (ELVs). Therefore, CSP is proposing to increase the capacity of the treatment plant by 50%, thereby allowing it to treat and cover the generated flow from the Baalbeck area until at least the year 2032, ensuring that the Al Massil natural stream would receive treated effluent instead of raw sewage.

ENGINEERING DESIGN AND CONSTRUCTION SPECIFICATIONS

CSP completed and submitted the 100% design packages of the five originally selected interventions (excluding Izal), and obtained approval for one of them (Sainiq), which will be forwarded to SLWE for possible future implementation, as explained above. Meanwhile CSP reviewed and addressed comments from USAID's Architecture and Engineering (A&E) Mission Support Program (MSP) contractor. Each design submittal underwent multiple review cycles which caused delays in obtaining USAID approvals. In June, CSP and the A&E MSP contractor attended a USAID workshop to discuss ways to streamline the process. The table below reflects CSP's wastewater infrastructure

interventions within the program's construction budget and timeline, as well as their design status as of June 2021.




Parallel to the design process, CSP submitted the Initial Environmental Examination (IEE) for Aitanit Wastewater Treatment Plant (WWTP) rehabilitation and sludge management to the Ministry of Environment (MoE). The remaining IEEs are under development and will be submitted during the next quarter, excluding the laat WWTP rehabilitation and expansion as it might require an Environmental Impact Assessment (EIA). Meanwhile, CSP's environmental subcontractor, Earth Link and Advanced Resources Development's (ELARD) is developing a scoping report for laat's EIA to be submitted to MoE, expected to be received during the next quarter.

In addition, USAID approved the environmental review and assessment checklists (ERACs) for Borj Rahhal, Nmairiye, laat rehabilitation, Aaitanit and Sainiq, which were submitted during the first quarter. The ERACs for Bchaaleh, Lower Litani and laat's Expansion component will be developed and submitted to USAID next quarter. These checklists will be incorporated into construction subcontractor tender documents to ensure environmental specification compliance.

WASTEWATER INVESTMENT

On April 8, 2021, CSP held the virtual launching ceremony of the Industrial Wastewater Treatment (IWT) project, which aims to support Lebanese industries willing to invest in proper onsite industrial wastewater treatment, in partnership with the Association of Lebanese Industrialists (ALI). The event was attended by the U.S. Ambassador to Lebanon, USAID's Mission Director to Lebanon, President of ALI, And Prepresentatives from ALI and regional chambers of commerce. The industry and agriculture sectors were also represented, as well as USAID's implementing partners. During the event, CSP screened an infographic video promoting the project, and ALI announced that seven agri-food industries were interested in the IWT project. A press release on the launch was disseminated in English and Arabic and published in more than 30 local media outlets.

Following the launching ceremony, CSP, ALI, and Environmental Consultant ECODIT Liban conducted introductory visits to the interested industries to determine their eligibility as part of the development of a baseline assessment report required under the grant agreement. Two of the initial seven interested industries were deemed ineligible, as one of them refused to grant access to their production facility, whilst the other had a well-operated secondary wastewater treatment system installed but was seeking advanced treatment to enable them to reuse the water. Subsequently, ALI secured two replacement industries, one of which was found to have installed industrial wastewater pretreatment equipment but was not operating it properly. Therefore, by the end of this quarter, six industries could be eligible to benefit from the IWT rebate program. Accordingly, ECODIT Liban conducted the six associated baseline

assessments, including the collection of industrial wastewater samples. In addition, ECODIT Liban submitted two baseline assessment reports during the month of June 2021. ALI also started working on securing a seventh industry that could benefit from the IWT project.

IMPLEMENTATION CHALLENGES, MITIGATION MEASURES, AND NEXT STEPS

During this quarter, CSP and its subcontractors continued to leverage their close working relationships with high-level officials at RWEs, the MoE, and the MoEW in order to push the environmental permitting process forward and secure all legal requirements needed for implementation. Unfortunately, CSP's partners at the RWEs are experiencing severe hardships and lacking essential resources to provide their mandated water and wastewater services, which raises serious concerns regarding their ability to operate, maintain and sustain the planned infrastructure. As the country sinks into a deteriorating socio-economic crisis, discussions on how best to mitigate associated challenges are being held across the donor community and implementing partners.

Despite the country's volatile context, CSP expects to continue with the preparation for the implementation of its wastewater management program in the next quarter, as outlined in its FY2021 work plan. CSP looks forward to receiving approval of the 100% designs for Borj Rahhal WWPS & Forcemain, Aaitanit, Nmairiye, and laat Rehabilitation, anticipated during the upcoming quarter to remain on schedule with these interventions. CSP equally expects to start the bidding process shortly after, while obtaining approvals for the Lower Litani Trunk Sewer, Bchaaleh wastewater system, and laat Expansion during the first quarter of FY2022.

VI. TECHNICAL ASSISTANCE AND CAPACITY BUILDING

CSP's technical assistance & capacity building component, also known as Task Order 3 (TO 3), complements the program's community support, workforce development, and wastewater management activities by ensuring that recipients of assistance possess the know-how, skills, and tools to maximize the impact and sustainability of USAID investments.


Throughout this quarter, CSP's TO 3 continued to conduct technical training and capacity building activities to municipalities, civil society organizations (CSOs), and community-based organizations (CBOs) across Lebanon. This assistance gives CSP partners the opportunity to improve organizational development, financial management, social media management, and the operation and maintenance of donated equipment.

TECHNICAL ASSISTANCE

ASSESSMENT REPORTS: This quarter, CSP designed and submitted nine technical assistance proposals — or technical assistance assessment reports (TAARs) for USAID approval achieving a total of 70 designed TAARs, out of a cumulative target of 75 for CSP's third year of implementation. The submitted TAARs included community capacity building interventions for the operation and maintenance of USAID provided equipment such as generators, rainwater pipes and hybrid photovoltaic systems; as well as technical assistance interventions for local authorities on financial management and raising awareness on sorting-at-source.

TRAINING DAYS: Over this quarter, CSP also conducted 387 training days, out of a target of 150¹, where 219 additional unique trainees benefitted from capacity building training sessions, compared to a target of 50 for the quarter. By June 2021, CSP had trained a cumulative 831 unique trainees, exceeding its target of 350 by 237% for CSP's third year of implementation.





¹ The numbers mentioned in this section may be different from those stated in the MEL section of the CSP IDIQ quarterly. The reason for the discrepancy is that while TO3 reports on actual implementation numbers, MEL reports only on completed trainings (at the output indicators level) and completed TAARs (at the outcome indicators level). Since TO3 has completed only 8 TAARs at the end of Q2Y2, while implementing an additional 26 TAARs, reporting numbers may vary.

INTERNS: As part of its partnership with USAID's University Scholarship Program (USP), CSP recruited seven additional interns this quarter, raising the total number of hired USP/CSP interns to 32, against a target of 30 during CSP's third year of implementation.

INSTITUTIONAL ADAPTATIONS AND IMPROVEMENTS: Between April and June 2021, 13 improvements to local partner internal systems were reported as partners develop enhanced organizational policies and procedures following CSP capacity building interventions. 13 institutional adaptations were also reported as local partners implement their improved policies and procedures following CSP technical assistance trainings. With the yearly target for institutional adaptations set at 18, CSP has already reached 72% of its target by the end of the third quarter.

MOBILIZED FUNDS: This quarter, and as a result of CSP's capacity building support to SADA NGO and the Qaa Municipality, both local actors were able to mobilize a total of enabling them to implement community-based projects in the Beqaa region. It is worth noting that this outcome is set for CSP's fourth year of implementation, however the team was able to achieve this result by the third quarter of CSP's third year of implementation.

TECHNICAL ASSISTANCE TO MUNICIPALITIES, CIVIL SOCIETY ORGANIZATIONS, AND COMMUNITY-BASED ORGANIZATIONS

FIELD VISITS AND DESIGN OF TECHNICAL ASSISTANCE INTERVENTIONS

As previously mentioned, CSP designed nine TAARs during this quarter, including a community of practice on generator management targeting 12 local actors. The TAARs also included raising awareness on best practices regarding sorting from source, as well as the operation and maintenance of equipment such as a rainwater pipes and channels, and hybrid photovoltaic systems.

CSP also conducted 54 on-the-job trainings and carried out ten profiling visits: five in the Beqaa, two in the South, and three in the North. This raises the total number of CSP's capacity building field visits to 233, averaging twelve visits per month across the project's lifecycle.

IMPLEMENTATION OF TECHNICAL ASSISTANCE

SUMMARY OF IMPLEMENTATION PROGRESS: By the end of the third quarter, CSP was implementing 28 TAARs; meanwhile 21 are pending implementation, and 13 have been concluded. Of the 28 activities under implementation, ten are in the North, six in the Beqaa, six in the South, and another six across Lebanon. The completed TAARs include conducting training and workshops to cooperatives of olive farmers on the operation and maintenance of olive oil processors previously provided by CSP, assisting members of women's cooperatives in business planning and bookkeeping, and improving the capacity of municipalities to safely maintain solar-powered lightbulbs and better

engage with communities through improved social media management and participatory approaches to governance. A breakdown of TAAR analytics for this quarter is illustrated in the visual below.




IMPLEMENTATION THROUGH SERVICE PROVIDERS: During this reporting quarter, CSP's TO3 contracted two additional service providers to offer new trainings and capacity building to communities benefiting from CSP interventions. The NGO, "Terre Liban", was contracted to conduct training and awareness-raising sessions with more than 15 communities in the Bechmezzine area to improve sorting from source. Agri-Dev was also contracted to design and roll out an asset management system for CSP-provided equipment and material in the field. Agri-Dev will be training CSP's local partners on recording the status, locations and custody of donor-provided equipment. Below is a list of service providers currently contracted by TO 3, and their respective budgets and allocated funds.

ON-THE-JOB TRAININGS: CSP provided 54 on-the-job trainings during this current quarter, representing more than in allocated funds and benefitting some additional 219 unique trainees. 
COLLABORATION BETWEEN THE TASK ORDERS

DIRECT COMMUNITY SUPPORT

During the reporting quarter, the technical assistance team reviewed three community support concept notes, three Approved Activity Packages (AAPs), and five Environmental Review and Assessment Checklists (ERACs). In parallel, the team produced eight TAARs aiming to ensure the sustainability of USAID equipment provided under direct community support. The visual on the right illustrates the geographical distribution of TAARs complementing direct community support activities.

WORKFORCE DEVELOPMENT

CSP initiated its organizational capacity assessments of Technical, Vocational, Education and Training (TVET) private partner institutions, receiving assistance under CSP's workforce development component. This activity allows the assessment of TVETs' institutional and organizational capacities in governance, planning, management, HR, and financial management, and aims to identify the best technical assistance strategies to improve the TVET sector in Lebanon. On June 14, CSP conducted its first capacity assessment at St. Elie Vocational Training Institute at Al-Mina, North Lebanon. Going forward, the team plans to conclude all organizational assessments of CSP's partner TVETs in the next quarter, before presenting the overall results and recommendations to USAID.

WASTEWATER MANAGEMENT

During the quarter, CSP initiated the technical assistance design of wastewater management activities including an intervention to the Beqaa Water Establishment (BWE) and the Municipal Union of Al Bouhaira on building employees' capacities in operating and managing Aitanit's wastewater treatment plant ahead of CSP's upcoming upgrades and rehabilitation of the plant. In parallel, CSP's technical assistance and wastewater management teams are working to develop a technical assistance package to complement CSP's wastewater interventions in Nmairiye. The package is expected to be finalized in the upcoming quarter, which would ensure that technical assistance to large wastewater interventions is implemented simultaneously thereby maximizing the impact of the intervention within the community and minimizing implementation risks.

CROSS-CUTTING TECHNICAL ASSISTANCE

CLUSTER TRAININGS

This quarter, CSP launched and concluded five regional trainings on social media, conducted in the North, South and the Beqaa. The trainings were attended by participants from all CSP beneficiary communities including municipalities and cooperatives. The content included techniques for designing good social medial strategies and improved management and measurement of social media campaigns. The cluster trainings on social media are being followed up by two CSP/USP interns who have closely reviewed CSP local partner existing social media channels. The interns, in collaboration with CSP's communications specialist, are now working with local partners to improve content and outreach of their platforms while enhancing effective communication with their targeted communities.

COMMUNITIES OF PRACTICE

On June 18, 2021, CSP held the Recyclables Waste Management (RWM) Community of Practice (CoP) inception workshop at the Padova Sin El-Fil, in Beirut. This Community of Practice aims at bringing together up to 54 municipalities and local organizations already benefitting from the USAID-funded CSP and DAWERR assistance and organize them within a recyclables waste management network to share lessons learned, best practices and successes, and develop new, efficient services to local communities. The workshop, with the participation of three solid waste management experts, was attended by 32 local stakeholders representing 25 municipalities, two material recovery facilities (MRFs), and one collection facility (CF), as well as four civil society organizations (CSOs).

During the workshop, participants agreed on the following road map for the RWM CoP:

- I Produce a model for Private Public Partnership (PPP)
- 2 Developing an incentive mechanism
- **3.** Develop guidance on feasibility plans for CoP members
- 4 Create an e-library platform to share information and best-practices
- 5 Develop a coordination process with DAWERR.

In the upcoming quarter, CSP aims to finalize and launch virtual platforms to facilitate an information-sharing system between RWM CoP participants, conducive to sustaining improved practices and a continuous learning process. The platforms will be used to communicate, collaborate, share resources and information, and conduct webinars and workshops on topics related to RWM. These would include the legal framework for municipalities to manage the communities' recyclables locally, recyclables recovery work, storage and sales, and workers' safety and security. The platforms will also include tip sheets, guidelines, new processes and best practices on recyclables management.

In addition to launching the RWM CoP, CSP finalized the design of the Generators' Management (GM) CoP, which will cover financial feasibility, sustainability, and transparency in managing power generators provided to communities by USAID under CSP. The GM CoP will be implemented in the next quarter and will extend to some 15 communities already benefiting from CSP interventions, as well as other USAID-supported communities under different implementing partners.

USAID COMPLIANCE TRAINING

To improve the compliance of CSP service providers, grantees, and contractors with USAID regulations, the technical assessment team facilitated the design and delivery of a series of compliance trainings covering grants management, vetting and due diligence, monitoring and evaluation requirements, cash for work, and branding and marketing. On June 25, 2021, CSP conducted an event to launch the training series, discuss its objectives, and encourage the participation of the largest number of CSP partners.

The training series is expected to be delivered during July and August 2021 after which TO3 will assess the overall results of the training series and recommend ways forward.

TECHNICAL ASSISTANCE HIGHLIGHTS

MUNICIPALITIES

CSP continued providing technical assistance to 32 municipalities this quarter, nine of which are in

South Lebanon, nine in the Beqaa, and 14 in North Lebanon, in addition to one union of municipalities - the Union of Hasbani.

This quarter, in South Lebanon, CSP initiated a series of trainings and OJTs in Saida municipality on public procurement with the participation of relevant employees and municipal council members. Meanwhile in the Beqaa, CSP is building the capacities of three municipalities (Dahr el Ahmar, Aaiha and Deir El Ghazal) to develop specific budgets for the operation and maintenance of the generators previously provided by USAID through CSP. Alongside financial and technical experts, CSP met

with each of the three municipalities and discussed the maintenance budget that is going to be developed based on the technical specifications required by the generators' supplier. Each of the three municipalities provided a signed commitment indicating their willingness to adhere to this budget/plan and engage in all upcoming trainings specific to its implementation.

In North Lebanon, CSP conducted a Training of Trainers (ToT) for the Bechmizzine partner villages ahead of developing and implementing an awareness campaign on sorting at source; participants included representatives from ten municipalities and four villages. Furthermore, CSP conducted inception meetings with 18 partner villages in the Bechmizzine area to launch the sorting-at-source activity, followed by TOT trainings aimed at preparing 'community champions' who will support in the implementation of the campaign and ensure its sustainability after project completion.

Additionally, during the quarter, the technical assistance team ramped up cluster trainings. In the South, CSP conducted its last batch of proposal writing cluster trainings to participants from eight municipalities and one union of municipalities and began on-the-job trainings with the same trainees to develop complete funding proposals - enabling them to increase their access to resources channeled towards local development and stabilization in their communities. In parallel, CSP also conducted four cluster trainings on social media measurement and management to 13 municipalities in North Lebanon, six in the South, and seven in the Beqaa.

Furthermore, CSP concluded its technical assistance interventions to build the capacities of four local partners in maintaining USAID funded equipment previously provided through CSP. In the Beqaa, CSP improved the capacities of El Khiara municipality to safely maintain solar-powered lightbulbs, as well as enhanced Tannoura municipality in maintaining a generator and strengthening its financial management. Meanwhile, in the South, CSP improved the capacity of the Rachaya el Foukhar municipality in safely maintaining LED lightbulbs and developing a municipal strategic framework; as well as enhanced the capacity of the Tanbourit Olive Farmers' Cooperative to operate, schedule the use of, and maintain mechanical olive harvesters.

WATER ESTABLISHMENTS

CSP continued providing technical assistance and support to Regional Water Establishments (RWEs) on the operation and maintenance of the Enterprise Resource Planning (ERP) software, initially designed and installed by USAID'S Lebanon Water Project (LWP). Following the renewal of the Begaa Lebanon Water Establishment's (BLWE) Nav-Dynamics software license, required to operate the ERP system, last guarter, CSP also renewed the licenses in the South Lebanon Water Establishment (SLWE) and North Lebanon Water Establishment (NLWE) this quarter.

In addition, CSP provided daily technical assistance support to NLWE, namely the Tripoli main branch, where ERP experts trained and supported relevant staff to generate bills to around 75,000 residents. In addition, CSP was able to migrate data from the existing X7 system to the newly installed ERP system in five branches: Koura, Batroun, Halba, Qobayyat and Minieh - the latter of which had no previous access to the ERP system. CSP plans to conclude data migration operations in all NLWE branches by the end of July 2021, resulting in all NLWE operations being conducted through USAID's ERP for the first time since its installation, and enabling the establishment to efficiently produce income statement and balance sheets and submit them to relevant authorities.

Furthermore, CSP's ERP expert provided day-to-day support to BWE and SLWE staff using the ERP system, particularly in the payroll and accounting departments, enabling employees to continue their daily work operations on the ERP without having to revert back to the existing Excel-based system. By the end of the quarter, all three RWEs have developed clear action plans and Gantt charts, and are following up with CSP's ERP expert on implementation progress on a weekly basis. CSP is also conducting monthly progress meetings with RWE Directors to ensure a fortified, sustainable handover of the ERP systems in the three RWEs by end of October 2021.

COOPERATIVES / SMALL AND MEDIUM ENTERPRISES

In addition to concluding its technical assistance interventions with the Akroum Olive Farmers' and the all-women Jdaidet El Qaitaa COOPs, CSP is continuing its capacity building support to the Fnaideq COOP in Akkar; the team had previously trained the members of the COOP on brand management, promotion, advertising, and product pricing strategies following the provision of a mobile kiosk to improve the cooperative's access to local markets. This quarter, and with the objective of increasing the sales of the Fnaideq COOP, CSP trained its members on improved networking, and is currently supporting them in developing market linkages with ecotourism groups that organize activities in the area.

Furthermore, CSP initiated technical assistance interventions to the Ainata and Fissan COOPs. In Ainata, CSP's service provider, Asquare, conducted an in-depth capacity assessment that identified the need to pursue capacity building activities aiming at enhancing the COOP's sales. Meanwhile, in Fissane, and with the support of two USP interns, CSP trained the COOP members on the operation, maintenance, storage, and safety measures of the pruning shears previously provided by CSP to improve the quality of agricultural practices and contribute

to income-generating activities. The two interns followed up by producing guidelines, tip sheets and checklists for the COOP's future reference. In the upcoming months, the interns will provide further operation and maintenance trainings to the Fissane COOP on the CSP-provided agricultural rotary tillers and manual tiller trailers. The interns will also develop operation and scheduling plans, allowing COOP members to manage equipment rental processes properly and transparently.

SCHOOLS

During this quarter, CSP continued providing technical assistance to three schools in North Lebanon: Al Mourabia Marzouka Al Mouzakzek, Al Salam and Qabait. Following CSP's capacity building to the three schools on the preservation of school properties, teachers and students produced short videos and drawings to raise awareness and encourage the preservation of school properties; the videos were shared on the schools' social media platforms to maximize outreach.

In parallel, CSP concluded its public safety technical assistance interventions in Al Salam and Marzouka schools. Following the training, the Marzouka school developed a comprehensive safety plan to ensure students' safety, including roles and responsibilities and actions to be taken in case of emergency. Meanwhile, CSP is still working with the Qabaait school on finalizing a tailored safety plan.

In addition, CSP's service provider, CEEDD-USJ, concluded water

conservation awareness-raising activities in Marzouka school in June 2021. Following trainings and guidelines provided to school personnel, 11 teachers and 74 students produced short videos and drawings aiming to raise awareness on water conservation. CEEDD-USJ then offered prizes for the best videos and drawings to encourage more students to take part in awareness raising activities.

COMMUNITY SUPPORT ORGANIZATIONS

CSP continues to provide technical assistance support to SADA NGO on the implementation of assets and cash management policies and expects to conclude this intervention during the upcoming

quarter. In addition, and in collaboration with Namaa NGO, CSP facilitated the assembly of a Town Hall meeting on May 22 to launch its 'sorting from source' activity in Ras Nhash. The meeting was attended by 28 community members, during which CSP discussed and clarified planned activities within the community and addressed members' queries and concerns.

COLLABORATIVE PARTNERSHIP WITH THE UNIVERSITY SCHOLARSHIP PROGRAM

As mentioned in the introduction of this section, 13 new students from USAID's University Scholarship Program (USP) at the Lebanese American University (LAU) and the American University of Beirut (AUB) have started their internships at CSP this quarter, bringing the total number of CSP/USP interns to 32. Meanwhile, four interns have finalized their internships, raising the total number of intern graduates at CSP to 15. The internships include a wide array of professional development work assignments, including provision of technical assistance to CSP's field activities under different task orders, enhancing local partner online platforms, and conducting desk reviews for upcoming campaigns. In parallel, CSP continued implementing its mentorship program that matches CSP/USP interns (mentees) with senior CSP staff members (mentors) based on their respective academic and professional backgrounds to discuss job readiness, career planning, leadership, work-based learning, and teamwork. During this quarter, five interns were working with various CSP mentors. The visuals below provide more information on the ongoing as well as concluded internships during the reporting quarter.

IMPLEMENTATION CHALLENGES, MITIGATION MEASURES, AND NEXT STEPS

Adapting to the challenging operating context at a national level, CSP's TO 3 was able to meet most of its targets during this reporting quarter. However, due to delays in TO 2 activity implementation resulting from the worsening economic and fuel crisis and nationwide protests and roadblocks, TO 3 expects to conclude technical assistance interventions in 18 communities instead of a target of 23 in the upcoming quarter. The devaluation of the national currency affected TO 2 suppliers' ability to import needed equipment, and nationwide roadblocks forced governmental institutions, local authorities, and private businesses to slow works down, causing implementation delays in communities such as Saida, Loussiya, EL-Marj, Al-Karaoun, Ansar, Beirut, Kfar-Jarra, and Qrayyeh. In turn, respective capacity building interventions were also forced to be delayed.

Despite the difficulties, TO3 had already exceeded more than 90% of its targets for the third year of implementation during the third quarter. Going forward, CSP plans to ramp up the closing of Technical Assistance Assessment Reports in targeted communities.

VII. MANAGEMENT AND OPERATIONS

CSP's management team, Task Order 1 (TO 1), provides centralized operational and cross-cutting technical support to all task orders under the CSP IDIQ. Despite the current reporting period being characterized by the gradual easing of lockdown measures, CSP offices continued to be officially closed for the first two months of the quarter, and partially re-opened at 30% capacity throughout the month of June. Field operations and visits were conducted without significant interruptions. Throughout this transition, TO 1 maintained business continuity and provided continuous support to CSP's other task orders to deliver on programmatic objectives. The rest of this section details the management team's achievements and progress throughout the past quarter.

MANAGEMENT AND OPERATIONS

ADAPTIVE MANAGEMENT

In accordance with the government's re-opening guidance, and observing great caution given ongoing risks associated with COVID-19, CSP maintained office closure and imposed remote work arrangements throughout April and May, while the partial re-opening of the offices at 30% capacity started in June. With the gradual easing of restrictions in April and May, staff could still carry out some essential tasks from the office during authorized hours with approval from the chief of party (COP). Despite these restrictions, CSP management and operations continued to facilitate the ability of staff to work productively from their homes, as support departments were largely able to fulfill their responsibilities remotely.

In parallel, field work returned to normal at the beginning of the quarter, allowing engineering and procurement teams to catch up on delayed tasks, while CSP continued finalizing preparatory and administrative tasks, internally and with partners, which were ready by the time lockdown restrictions were lifted.

MID-TERM REVIEW

In May, CSP conducted a mid-year review session, with the participation of the entire staff. While most staff attended virtually on Microsoft Teams, a small group of presenters was physically present in the office. The event presented an opportunity for CSP to pause and reflect on overall progress, discuss obstacles and challenges to implementation, and chart the way forward to maximize results and development impact, especially given the changing context in the country. HUMAN RESOURCES



ACCOUNTING AND FINANCE

During the third quarter of FY2021, CSP maintained its activities, progress, and spending despite the increased risk of curfews, closures, protests, fuel scarcity, hyperinflation, electricity outages, and the social unrest caused by the deteriorating economic situation in Lebanon. This section presents a detailed summary of spending across each task order, including explanations of variances in expected expenditure and shifting trends from the previous quarter and fiscal year. For a detailed breakdown of CSP expenditures during the reporting period, see Annex H.

TO I expended a total of this quarter, with an average burn rate of per month. Building on the momentum generated in the two previous quarters, TO I showed the highest subcontractor engagement of the fiscal year yet by local partners Quantum, BTD and ELARD, expending for construction design, supervision, and environmental compliance associated with TO 2 activities, as well as communications and outreach expertise for the IDIQ. TO 2 spent a total of with an per month during average burn rate of this quarter. TO2 not only succeeded in achieving a total of 88 approved activities against its target of 89, but also showed increased spending in the activity fund totaling with grants spending totaling an additional . As mentioned above, TO 2 also submitted 3 additional concept notes to achieve the 89 activities target, setting the task order up for increased spending in the next quarter. TO 3 expended with an average per month during this burn rate of quarter. TO 3 continued to deliver trainings through local partners and adapted effectively to complement TO 2 activities. In coordination with



the USAID funded program, "Diverting Waste by Encouraging Reuse and Recycling" (DAWERR), CSP launched the Recyclables Waste Management Community of Practice on June 18. The event included 35 local actors from communities implementing waste management and reduction projects with the support of CSP, in the North, South, and Beqaa regions. The team also launched the "CSP Training Series on Compliance" to CSP's service providers, experts, grantees, and contractors.

Finally, TO 5 expended a total of with an average burn rate of per month. In collaboration with ECODIT Liban and Association of Lebanon Industrialists (ALI), TO 5 conducted introductory filed visits to various industries to discuss upgrades to onsite wastewater treatment systems. In April 2021, TO 5 conducted a virtual launch ceremony for the partnership with ALI, completing Deliverable 8. TO 5 costs are expected to increase in the next quarter as construction designs are approved and the team can move towards the implementation phase.

GRANTS AND SUBCONTRACTS WITH INSTITUTIONAL PARTNERS

During the reporting period, CSP coordinated closely with construction quality control subcontractor, Bureau Technique pour le Développement (BTD) and environmental services subcontractor, Earth Link and Advanced Resources Development (ELARD), to ensure quality

interventions. These partners provide engineering design, construction site supervision, and environmental compliance services for several ongoing and potential interventions under CSP's community support, wastewater management, and workforce development components.

In addition, CSP issued a modification to the ongoing time and materials subcontract with institutional communications and outreach partner Quantum. The modification adds a new Reporting Officer, following the resignation of the former Reporting Officer,

VETTING

CSP adheres to USAID's Vetting Mission Order 15/03, relating to the National Security Screening of Awards, and has established a system to gather information from partners and beneficiaries at the field level to expedite the vetting process to key individuals. All of the submissions of partner information forms during this quarter were logged using the vetting tracker, as shown in Annex I.

CROSS-CUTTING TECHNICAL SUPPORT

ENGINEERING AND ENVIRONMENTAL COMPLIANCE

As this quarter witnessed the gradual easing of the prolonged COVID-19 restrictions, several activities requiring input from the engineering department, which were delayed due to last quarter's lockdown measures, received immediate attention and were expedited as much as possible. For instance, in Ras Baalbek, the contractor immediately reinitiated the rehabilitation of the village's irrigation system after the easing of lockdown, which led in the successful completion of the works. As a result, the whole irrigation system became fully functional and targeted beneficiaries were satisfied with the immediate results achieved.

As previously mentioned, however, this quarter presented its own set of challenges for the team due to the continued deterioration of the economy and the further devaluation of the national currency. These have been manifested through the shortages in market supply of construction materials and other related equipment, in addition to fuel crises starting at the end of the quarter. Showcasing the effects of these challenges, the construction of a water tower in Bqasta has been drastically delayed at the concrete-pouring stage due to the lack of supplies needed to generate the concrete. Adding to this, CSP's subcontractor and staff faced difficulties visiting the site as they lacked fuel in their personal modes of transportation. Moreover, other delays were experienced due to the security situation, such as under the Al-Mhammara activity, where technical kickoff and site handover was rescheduled four times within ten days due to roadblocks and civil unrest.

Finally, a stakeholder coordination meeting took place during this quarter between USAID, CSP, and A&E-MSP which reviewed the critical processes, roles, and responsibilities of each party. The meeting concluded with important commitment from all participants to streamline the QA/QC processes, mainly in shortening the design review cycles and the close-out procedures. Some important agreements which were reached during this meeting are listed below:

- Optimize the review cycle according to level of risk, type, purpose, and complexity of project that is reflected in the approved ARAR, classifying the overall activity risk from an engineering and construction perspective as low, medium, or high-risk activity.
- Shorten the design review cycles by conducting joint meetings between CSP and A&E MSP after the first round of design comments to expedite unresolved issues. Through the joint

efforts of CSP, BTD, and CDM in discussing comments directly upon receipt, these meetings aim to reduce the number of CSP response rounds.

- Ensure that the impact and scheduling of priority activities are drivers of project resourcing,
 while maintaining collaborative coordination.
- Shorten the close-out process, especially for the AQCP classified activities, by generating a
 pre-requisite checklist provided by A&E-MSP, related mainly to generators and streetlighting
 projects, to expedite the implementation and completion verification processes and to avoid
 several rounds of completion verification site visits and action item lists.
- Optimize/Expedite the issuance of the Substantial Completion verification reports produced by A&E-MSP by taking into consideration the observed comments and recommendations' significance and relevance to the approved intervention and its impact.

MONITORING, EVALUATION, AND LEARNING

During this quarter, the monitoring, evaluation, and learning (MEL) department focused on the following activities:

FINALIZING MEL PLANS On June 7, 2021, an adjusted CSP TO 3 MEL Plan was shared with USAID for revision and approval. These adjustments came because of the following:

- © Experience from the first of year implementation
- The need to calibrate the targets of TO 3 with the reduction of TO 2 targets
- ② Suggested TO 3 contract changes previously submitted to COR.

The updated targets focus on the implementation of 89 activities based on a no-cost extension scenario that would extend TO 2's period of performance to April 13, 2022. On June 28, 2021, an updated CSP TO 5 IPTT with yearly targets was sent to Social Impact, upon their request.

UNIFIED LOGICAL FRAMEWORK On the 18th of June 2021, the overall results framework for CSP was submitted to USAID. This was recommended by Social Impact as a next step after having finalized the MEL Plans for the different task traders. It depicts how the work of the various task orders contributes to the overall goal of the program.

COMMUNICATIONS AND OUTREACH

During this quarter, the communications and outreach unit recruited reporting officer, seconded through CSP's subcontractor, Quantum. Meanwhile, the team progressed on submitting outreach deliverables, finalizing the translation of the CSP website, enhancing local partner compliance on visibility, and supporting the program's technical TOs on branding and virtual events.

BRANDING AND VISIBILITY GUIDELINES

As CSP's local partners progressed in implementation, the communications unit finalized a 'Branding and Visibility Guideline for Partners and Sub-contractors', aiming to provide summary guidelines to service providers across all task orders on USAID branding and visibility compliance for activities implemented through CSP. The document also clarified branding approval lead times and status of visibility material following activity completion, as well as addressing coordination mechanisms for print material, online communications, and high-profile events/visits to ensure timeliness of outreach material. In that regard, the CSP communications director will deliver a branding training to all service providers participating in the series of compliance trainings facilitated by TO 3 in the upcoming quarter.

AUDIO-VISUAL MATERIAL

This quarter, CSP produced and disseminated an infographic <u>video</u> illustrating CSP's rebate program with the Association of Lebanese Industrialists (ALI) under the Industrial Wastewater Treatment (IWT). Meanwhile, CSP produced and disseminated another <u>video</u> promoting positive perceptions of the repair and maintenance (R&M) sector in Lebanon, aiming to solicit applicants for the upcoming R&M vocational course provided under CSP's workforce development component. Both videos generated more than 50,000 views on CSP's social media platforms.

In addition, by the end of June, the communications team was in the process of finalizing two other videos: the first on CSP's interventions with the Fneideq agricultural COOP, and the second on streetlighting interventions in the villages of El Khiara, Niha and Rashaya el Foukhar. Finally, in its efforts to ramp up the production of audio-visual material, the team is in the process of preparing a video on CSP's streetlight interventions in Beirut following the Port blast, and a video on sorting-at-source activities in South Lebanon.

VIRTUAL AND HYBRID EVENTS

The communications team led the implementation of the virtual launching ceremony of the IWT project on April 8. The event was attended by the U.S. Ambassador to Lebanon, USAID's Mission Director to Lebanon, and representatives from ALI and regional chambers of commerce. In addition, CSP held a meeting with the communications representative of USAID's DAWERR project to share lessons learnt and discuss best practices for launching hybrid events.

PRESS RELEASES

CSP disseminated two press releases this quarter in both English and Arabic. The first covered the virtual launching ceremony of the IWT project, and the second CSP's workforce development component ahead of launching the Technical and Vocational Education and Training (TVET) perception campaign in the upcoming quarter. Each press release was published in over 35 local media outlets.

TRANSFORMING LIVES STORIES

This quarter, CSP received USAID approval on three stories promoting CSP's internship program in coordination with USP, as well as village security enhancements following USAID streetlight interventions and income generating-opportunities. In addition, CSP submitted a new story for approval featuring a CSP/USP intern graduate who was recently awarded the Fulbright Scholarship to study Robotics and Controls in the U.S and aims to bring lasting innovation to Lebanon, offering a better future to its underserved communities after graduating.

STORY MAP

Produced to summarize the content of CSP's FY2021 Q2 progress report, the story map is designed using the online mapping software ArcGIS and conveys the report's contents to a general audience by combining narrative, audiovisuals, and interactive maps. Along with all previous CSP story maps, this is accessible through the CSP website.

SUPPORT TO TECHNICAL TASK ORDERS

The communications team continues to support all CSP's technical TOs by editing content and producing and disseminating visibility and outreach material. In addition to the above, the team supported TO2 in producing informative branding, construction plaques, and road signs for multiple interventions, while also supporting TO3 in producing training certificates and best practice posters.

WEBSITE TRANSLATION

During the quarter, the team finalized the Arabic translation of the CSP website which was launched last quarter in English. CSP will launch the Arabic website in the upcoming quarter to ensure enhanced outreach to CSP local partners and beneficiaries, as well as online and traditional local media outreach.

SOCIAL MEDIA

Since last reporting period, CSP's Facebook reach increased by over 700 followers to a total of 7,108 organic followers. CSP continues to share human-interest stories, testimonials, impact infographics, and other engaging material on its other social media platforms, including Instagram, Twitter, and LinkedIn.

GENDER EQUALITY AND WOMEN'S EMPOWERMENT

During this quarter, CSP established a Gender Equality and Social Inclusion (GESI) task force to increase women's participation and social inclusion within CSP through a range of activities, including building the technical capacities of its members and expanding targeted outreach. The task force finalized its scope of work, capacity development needs, and the GESI workplan, which includes prioritized activities to be completed by end of the current fiscal year. In this regard, the GESI TF contacted two well-known NGOs, KAFA and MOSAIC, that are leading female empowerment activities in Lebanon, and agreed with them to conduct a half-day training session for all CSP staff on gender inclusion. The training will take place during the next quarter.

Additionally, CSP GESI focal point and other task force members participated in the Chemonics GESI Focal Point Summit on June 24, 2021. The summit focused on fostering global workforce engagement among Chemonics GESI focal points, on creating an opportunity for focal points to share learnings and continue building cross-project communications, and on sharing key resources and opportunities. During the summit, CSP's GESI focal point gave a presentation on how CSP is challenging gender stereotypes and empowering women in a difficult socio-economic context.



, CSP GESI focal point, giving a presentation during the Chemonics GESI focal point summit on June 24.

LESSONS LEARNED AND NEXT STEPS

The compounding crises in Lebanon at the political, economic, and security levels continued to escalate during this quarter. In response, CSP's management team remained highly attuned to supporting staff to adapt and continue building resilience to respond to new and emerging community priorities. In this regard, the management team implemented various staff care practices aiming to alleviating morale throughout this quarter.

STAFF CARE

In April 2021, Atlas Assistance, CSP's security analytics partner, gave a 75-minute situation briefing related to the evolving political, economic, security context in Lebanon. While the outlook didn't provide an optimistic perspective for the country, staff appreciated the straightforward summary and analysis and were able to receive answers on some pressing concerns.

Also in April, CSP organized an internal "Panel Discussion: Living During Times of Economic Crisis" with two long-term Chemonics employees and COPs providing staff with advice about how to live and work during times of financial crisis. The panel delved into a detailed discussion of what life was like during times of crisis, major concerns and challenges experienced in such crises, and specific tactics employed while navigating this period. Staff gained valuable information from the discussion which helped them strategize means of adapting within the volatile context in Lebanon.

In June 2021, CSP was able to provide staff with Chemonics-sponsored access to the Pfizer vaccine. Staff and dependents from Chemonics' three ongoing projects benefited from 175 vaccines paid for by the company as part of the annual COP fund. The initial batch of 168 vaccines was administered on June 25 at a private vaccination center in Geitaoui Hospital. The second dose will be received in July 2021, along with the remaining first dose shots in August. This came as a great relief for staff and provided an opportunity for them to feel more confident in returning to working from the office, especially with the deterioration in public services such as internet and electricity access at home.

CSP MID-YEAR REVIEW

As per TO 1's Year 3 Workplan, CSP conducted its mid-year review on May 20, 2021. Most of CSP's 79-member team participated virtually, with a limited number of people joining in person from the office. CSP's Project Management Unit (PMU) also joined virtually from Washington, D.C. for the second half of the day. The review presented an opportunity for CSP to pause and reflect on progress, obstacles and challenges to implementation, and to look ahead for ways to maximize results and development impact in light of the changing context in Lebanon.

The opening session laid out CSP's progress and overall results for FY2021, along with CSP's CPARs for FY2020 and some achievements related to the established key priorities: thought leadership, outreach, and results. Following the opening session, the team focused the discussion on how to maintain CSP's relevance given the changing context. As a result, five major changes in the country context were highlighted: 1) increased impoverishment; 2) decreased municipal-level services; 3) decreased national-level services; 4) increased communal tensions; and 5) decreased individual and communal capacities. Following this, the team worked in breakout groups to explore how CSP could innovate to respond to emerging needs and shifting community priorities. In the second half of the day, the team focused on current operational and implementation challenges, and in a second set of breakout sessions, mitigation measures or solutions to address challenges were identified.

NEXT STEPS

Between the contextual changes and the implementation and operational challenges across the country, the team brainstormed several ways to either change how CSP is implementing current interventions or solutions and mitigation measures to overcome challenges. As a next step, a Working Group to select a few of the most relevant recommendations and ways to put them into action has been formulated. The Working Group was established to include one volunteer per task order who is not part of CSP's senior management team (SMT). This is an opportunity for staff outside the SMT to get involved, raise their profile, and have their voice heard. The Working Group met and presented the outcome of their meetings to the CSP SMT and is continuing to work on integrating the recommendations from the retreat into CSP operations and programming.



is what many Lebanese refer to in Arabic as bent ed dayaa — "a daughter of the village" who doesn't fail to respond to the needs of her community in Damour, a small village in Lebanon's Chouf area. Therefore, when USAID's Community Support Program (CSP) supported Damour in the wake of the wildfires in 2019, she immediately joined more than 150 local residents that were hired to carry out cleanup labor.

were asleep at home when the fires broke out. "We woke up surrounded by black smoke," she remembers. "People were screaming. We had to leave the house, so we just started running." The wildfires went on to burn more than 40 percent of Damour's land, ravaging houses and offices and destroying the public water and electricity networks.

Due to the deterioration of Lebanon's economy in the months that followed, Damour was unable to rehabilitate the damaged services or support residents like who were made vulnerable by the wildfires and the economic crisis. USAID's CSP activity responded by revitalizing the water and electricity networks. CSP then provided short-term work opportunities for residents by employing them to engage in pruning and waste removal to reduce fire risk in Damour and its surroundings.

signed up for the activity after hearing about it from a friend, and, for three months, between September and November 2020, she has showed up six days a week to cut back burned foliage and pick up recyclables and trash. Her dedication, Josiane says, comes from her love for Darnour. "We respect and take care of our land. If another fire erupts, it will not be like the last. We are children of this land." The activity also enabled Josiane to use the money she earned to cover essential needs like clothes and shoes for her children and home electricity generator expenses.

The activity is part of a larger USAID-backed initiative that is supporting the delivery of essential services and enhancing economic opportunities in underserved communities, primarily in Lebanon's North, South, and Beqaa Valley.
